

- 1. Sr. Vice Commandant Robert Hare
 - a) I want to start by saying thank you for all of the email, text, and phone calls when I had my emergency surgery. My wife was blown away by the camaraderie Marines have, so thank you again.
 - b) This report is going to be short. Unlike my report at the last meeting, I only visited 1 Detachment due to it having issues and they requested that I speak with the membership and observe their meeting. This was requested after other requests were conducted and not resolved to their satisfaction. I have not spoken with the Detachment since, so I won't be discussing my recommendations to the rest of the Detachments. If you did not attend the Commandant's Council earlier this morning, I will state that if you are not using the current forms sent down by National, I ask that your Adjutant and/or Paymaster go to the website and download them. When Detachments email me about issues they are having, especially with transmittals, it's hard to defend you when you're using the wrong forms. If you need assistance locating them, please let me know and I'll be happy to help you.
 - c) Most of my time has been spent on the investigation or audit of the AV equipment as requested and voted on by the membership. I will be providing a report on that later today. Hopefully, this will put this issue to bed so that I can focus on selling this equipment.
 - d) Fundraising has been a challenge to say the least. With the current event, which is the paid hotel stay w/spending cash to the 2024 National Convention in Palm Springs, California, it has sold 101 tickets totaling \$1,660 in revenue. With just this fundraiser only, I am

about \$200 in the red, however, we still have 84 days to go before we draw the winner. I'm not done and confident that I will increase that number. Unfortunately, because of my surgery, I was unable to attend the Mid-Winter Conference, I missed an opportunity to drop flyers around the area. So far during my tenure as your Senior Vice-Commandant, I have raised \$5,645 and according to my numbers, I have barely touched the \$6,500 expenditure budget.

- e) I was also attempting to set up a cruise package for the 250th Marine Corps Birthday. However, because of cruise line booking guidelines, I decided not to set that fundraiser up. Instead, I'm adding an additional firearm that will start Monday morning. It will be a Springfield Armory Hellcat Pro w/Crimson Trace Red Dot 9mm FDE Melonite (tan) 15+1 magazine capacity. I am also personally providing a 1-year membership to Right to Bear which is self-defense legal coverage. The winner will be drawn during lunch at the 2024 Department Convention in June.

- He has the national Jr Vice streamers which were not passed out from the previous Jr Vice. Please see him today to get your detachment's streamer.
- 3. Judge Advocate –Bill Brown
 - a) I can again report that during this quarter we had no instances of formal Grievances or Disciplinary Charges brought by the Detachments. I hope that the trend of resolving issues at the lowest level will prevail and that Chapter Nine actions are a last resort to resolve indifferences. There does continue to be instances that are truly more personal conflicts among members, many of whom serve in elected positions of their detachments, rather than anything of substance. We need to remember why we volunteered to serve in the positions for which we were nominated and elected or appointed to in support of our detachment and the League. In each officer's oath of installation we said, in part thereof "I will enforce and uphold and will myself OBEY the laws of the League...I will SUBORDINATE myself to the best interests of my fellow Marines, FMF Corpsmen and FMF Navy Chaplains and the Marine Corps League".
 - b) During this past quarter I worked with the Executive Board of Trustees to finalize the inventory and in reviewing documentation for the acquisition of the Department's Audio/Visual equipment. This proved to be a larger than expected undertaking but with information provided by Denny Mathia and DoNC Paymaster, Scott Shermeyer, we were able to reconcile that all A/V property was accounted for and on hand and that there was no instances of malice, wrongdoing or

misappropriation of Department funds. I then issued the Findings of the DoNC AV Acquisition and Inventory to the Department membership.

- c) As I reported in the Fall Membership meeting I updated the Department Bylaws for submission to the National Judge Advocate to approve the corrections required from our 2022 DoNC Bylaws submission in addition to the new language approved and at the 2023 DoNC Convention. How soon that may be approved I do not know as the NJAs backlog is sizeable at this time. I did make sure to go ahead and post them on our DoNC website and highlighted in color the applicable changes to facilitate a hopefully speedy review once reviewed. There are still new items to be incorporated from the 2023 National Convention that I have begun compiling them for the next update. If the items approved at the 2023 DoNC Convention and included in the updated bylaws are concurred with by the NJA, it will make changes in the DoNC Bylaws that mirror the National Convention changes easier to update without having to have approvals at our convention.
- d) As the Bylaws are a living document that require continuous update and revision/amendment, you are reminded that the deadline for submission of proposed changes to the National Bylaws and National Administrative Procedures (NBL/NAP) is 1 April 2024. They must be in the proper format and be addressed to the National Executive Director/Chief Operating Officer (NED/COO) See NAP Chapter Ten Section 10020 for specific information/instruction.

Submission can be sent via Email, Certified U.S. Mail, or by other carriers where certified delivery may be verified, and a return receipt may be requested. If the proposal is mailed, it is recommended that a PDF of the source document be emailed to the NED/COO. Additionally, the source document (MS Word, WordPerfect, etc.) shall be emailed to the NED/COO. Receipt of the email submission(s) will be acknowledged by the NED/COO.

The appropriate mailing and email addresses have been provided by the Department Adjutant.

Additionally, the 2024 Proposed DoNC Bylaws changes are due to the DoNC Bylaws Committee and/or Department Judge Advocate by 9 April 2024. The same applies to format as to NBL/NAP changes. I look forward to receiving and reviewing your suggestions and input.

- e) If you have not submitted a proposed change before and would like to have yours reviewed prior to actual submission, I will be glad to take a look at them as long as you don't wait to the last minute to do so.
- f) And I also made it known that I feel the Detachments should not be admonished for not having their bylaws updated; that the DoNC Bylaws must first be in order. To that end, numerous changes need to be made there as well as then updating the Sample Bylaws to reflect the latest changes. I have been reluctant to release the updated Sample Detachment Bylaws only because a number of changes are dependent upon approval of our DBL by the National Judge Advocate
- g) I do have two key proposed amendments that will be in the DBL and Sample Detachment bylaws.
 - i. NAP Section 6005Authority. Each detachment shall be governed by its elected officers (board of trustees) subordinate to the Department and National Conventions, the charter and the bylaws and administrative procedures of such bodies including such bylaws and procedures as it may itself promulgate which are not in conflict with either National and/or department Bylaws and Administrative Procedures
 - ii. NAP Section 10005 Respect. B. The "Ritual" of the Marine Corps League shall be observed and employed at all meetings and appropriate functions to the maximum extent possible.
- h) I received several Detachment Bylaws submissions over the quarter and have completed a couple of those updates. I notified each that my priority will be to update the DoNC Bylaws and Sample Bylaws but will work with the Detachments to get theirs in sync as well. Using conference calls and Zoom meetings to share documents and discuss recommended changes has worked well and I plan to continue this process. I have visited detachments when required to assist as needed.

 - b) The equipment was in the trailer locked in his garage. Everything was laid out in his garage to take inventory. Things such as cables were not measured / inventoried, etc. This was emailed to all elected officers.
 - c) Each elected officer individually went through the paperwork.
 - d) The officers then reached out to Scott Shermeyer for the financial data.
 - e) As EBOT, Denny Mathias and Ted Turner were on a meeting to answer questions. Those two then left the meeting.
 - f) There were a few discrepancies found and questions were asked and compared to expense receipt requests.

- g) It was found that there was \$30 pizza reimbursement which should not have been done. All other expenses / receipts were determined to match the bottom line.
- h) The equipment cannot be used to create a smaller system.
- i) The recommendation is to get rid of all equipment.
- j) It was put on the League market as requested by the department. No bites for purchase.
- k) It will now go to the open public market. Robert is not sure how long it will take to get posted.
- 1) Recommendation if not able to sell after all avenues are exhausted, we find a non-profit veteran group and/or a music school and donate.
- m) David Anderson email 1/24/24 from JA, #1 of letter, does all of the EBoT agree on this item?
 - i. AJ Pitts responded 3 of the 4 agreed on this number, however we are a team.
 - ii. This EBoT was making decisions based on things done by the EBoT before us.
 - iii. This has been an issue at the last several DoNC meetings.
 - iv. Yes, we agree there were a few things that were inappropriate. This has been going on since 2021. Robert and AJ were the new kids to this whole issue.
- n) David Anderson email 1/24/24 from JA, #8 of letter, the money of the sell of the equipment.
 - i. There was discussion (heated and non-heated) about the sale of the items and the use of the monies. Also, discussion about keeping any of the equipment and the trailer and the need for the trailer or any A/V equipment.
- o) Lewis Pleasant made motion to halt the sale effective today and donate all the equipment to a state funded school of the arts. Patrick Melton second.
 - i. This was attempted to be sold. It has not had any inquiries.
 - ii. Since it has not sold, we are looking to go to the open market. If we donate to a state music school will keep it in the state.
 - iii. The sale will be done / concluded by the convention in June.
 - iv. The EBoT was not trying to override any decision made by the members.
 - v. We have been trying to enact the motion to sale for the past 8 months.

- vi. Vote approved by members present.
- 4. Ric Ledford Budget & Finance Committee Member appointments
 - a) This shall be no less than 3 members.
 - i. Volunteers Kenny Joyner, Kevin Ashton, Betty Kramer, Keith Shearin.
 - b) Shall prepare a proposed annual budget consisting of appropriated and non-appropriated items for approval at the annual convention.
- 5. Lisa Ciesielksi NOD does not have to be filled out by any particular person in the detachment. Please fill out the form and get it emailed to her.
- 6. Keith Shearin what is the need for the trailer since the A/V to be donated.
 - a) There is still gear which is to be hauled in the trailer.
 - b) There are funds earmarked for fixing it.
 - c) The purpose of trailer is so the SoA does not have to pack their truck, but to leave gear in it.
- 7. Scott Shermeyer he found the error mentioned in the paymaster report for the interest and will correct it.
- 8. Bill Brown would like to have some help on the bylaws committee.
- 9. Bill Brown how many detachments who have money handled by members other than the Commandant or Paymaster. It includes anyone designated by the Commandant must be designated in writing.

 - b) Keith Shearin the other officers / DVC is for the travel to do their jobs. The ability to get reimbursed for hotel stay tells members that the person only comes become they get their hotel stay reimbursed.
 - c) Kenny Joyner it will need to be a bylaw change to separate the administration procedure from the bylaw.
 - d) Travel for chapter 9 is held to the department. This needs to be looked at.
 - e) Ric Ledford asks that this be tabled so the board and the members can look at this more.
 - f) Jim Hayes made the motion table to convention. Second by Bruce Goeden. Approved by members present.
